DISCLOSEABLE TRANSACTION

RELATING TO THE PROVISION OF LOAN FACILITY

The Board announces that on 4 June 2014, the Lender, an indirect wholly-owned subsidiary of the Company, entered into the Loan Agreement with the Borrower, under which the Lender has agreed to provide a loan facility of up to HK\$250,000,000 to the Borrower. The Loan Facility is available for drawdown upon signing the Loan Agreement, and shall be repaid within 12 months from the date of first drawdown.

Pursuant to Rule 14.06(2) of the Listing Rules, the granting of the Loan Facility constitutes a discloseable transaction of the Company as the relevant percentage ratio(s) exceed 5% but are under 25% and it is subject to the announcement requirement as set out in the Listing Rules but is exempt from shareholders' approval requirement under the Listing Rules.

The Board announces that on 4 June 2014, the Lender, an indirect wholly-owned subsidiary of the Company, entered into the Loan Agreement with the Borrower, under which the Lender has agreed to provide a loan facility of up to HK\$250,000,000 to the Borrower pursuant to the terms of the Loan Agreement.

THE LOAN AGREEMENT

Date: 4 June 2014

Lender: Emperor Finance Limited, an indirect wholly-owned subsidiary of the Company

Borrower: the borrower under the Loan Agreement

The Borrower is an individual. To the best knowledge, information and belief of the Directors having made all reasonable enquiries, the Borrower is an independent third party not connected with the Company or connected persons of the Company.

Principal terms of the Loan Agreement

Amount of the Loan Facility:	up to HK\$250,000,000
Drawdown:	available for drawdown upon signing the Loan Agreement
Repayment:	within 12 months from the date of first drawdown
Interest:	16% per annum
Security for the Loan Facility:	As a continuing security for the due performance of the obligations of the Borrower under the Loan Agreement, the Loan Facility is secured by :- (i) a share charge in favour of the Lender or its nominee by the Borrower for all his entire shareholdings in a holding company (which its subsidiaries are principally engaged in multi-media businesses) and any other ancillary documents; and (ii) all such securities as requested by the Lender from time to time.

REASONS FOR ENTERING INTO THE LOAN AGREEMENT

The principal business activity of the Company is investment holding and its subsidiaries are principally engaged in the provision of financial services in Hong Kong, including (i) brokerage services for securities, futures and options traded on the exchanges in Hong Kong, the United States, Japan and the United Kingdom, as well as wealth management and asset management services; (ii) margin and initial public offering financings as well as loans and advances such as personal money lending and second mortgage loan; (iii) placing and underwriting services; and (iv) corporate finance advisory services.

The Lender is a registered money lender holding a valid money lenders licence under the Money Lenders Ordinance (Chapter 163 of the Laws of Hong Kong) and is principally engaged in the business of money lending services. The provision of the Loan Facility is a transaction carried out as part of the ordinary and usual course of business activities of the Group. The Loan Facility will be funded by internal resources of the Group.

The terms of the Loan Agreement were arrived at after arm’s length negotiations between the Lender and the Borrower. Taking into account (i) the security for the Loan Facility, which includes, among other things, the value of the collaterals in respect of the Loan Facility; and (ii) the expected revenue to be generated and the attractive return to the Group, the Directors are of the view that the provision of the Loan Facility under the Loan Agreement is on normal commercial terms which are fair and reasonable and in the interests of the Company and its Shareholders as a whole.

IMPLICATIONS UNDER THE LISTING RULES

Pursuant to Rule 14.06(2) of the Listing Rules, the granting of the Loan Facility constitutes a discloseable transaction of the Company as the relevant percentage ratio(s) exceed 5% but are under 25% and it is subject to the announcement requirement as set out in the Listing Rules but is exempt from shareholders' approval requirement under the Listing Rules.
