DISCLOSEABLE TRANSACTION

PROVISION OF LOAN FACILITY

On 4 November 2022, the Lender entered into the Loan Agreement with the Borrowers in relation to the provision of the Loan Facility of up to HK\$17,000,000 which is available for drawdown subject to the terms therein and shall be repaid within 12 months from the date of drawdown.

The transaction contemplated under the Loan Agreement constitutes a discloseable transaction of the Company and is therefore subject to the announcement requirement but exempt from obtaining Shareholders' approval under Chapter 14 of the Listing Rules.

The Board announces that on 4 November 2022, the Lender entered into the Loan Agreement with the Borrowers. A summary of the details is set out as follows:

THE LOAN AGREEMENT

<i>Date</i>	: 4 November 2022
<i>Lender</i>	: Emperor Finance
<i>Borrower</i>	: the Borrowers
<i>Amount of Loan Facility</i>	: up to HK\$17,000,000
<i>Repayment</i>	: within 12 months from the date of drawdown
<i>Interest</i>	: (i) 14.8% per annum for the 1st month upon the date of drawdown (ii) 8.8% per annum for the 2nd month to 12th month upon the date of drawdown

Security for the Loan Facility : the Loan Facility is secured by a first mortgage over an industrial unit located in Sham Shui Po District, Kowloon, Hong Kong. Valuation on such property has been conducted by independent valuers on 22 September 2022 with average value of the said property being approximately HK\$32,000,000

Drawdown of the Loan Facility is subject to, inter alia, satisfactory credit assessment on the Borrowers by the Lender. The Borrowers are required to provide the Lender with other securities as requested by the Lender from time to time.

INFORMATION OF THE BORROWERS

Borrower I is wholly-owned by Borrower II which in turn is wholly-owned by Borrower III. Borrower III is owned as to 50% by Borrower IV and 50% by Borrower V. Borrower IV and Borrower V are merchants. The Borrowers are connected or associated with each other under the Listing Rules.

To the best knowledge, information and belief of the Directors after having made all reasonable enquiries, the Borrowers are Independent Third Parties.

REASONS FOR ENTERING INTO THE LOAN AGREEMENT

The Company is an investment holding company and its subsidiaries are principally engaged in the provision of financial services, including (i) commercial and personal lending as well as margin and initial public offering financing; (ii) brokerage services, wealth management and asset management; (iii) placing and underwriting services for listed issuers; and (iv) corporate finance advisory services.

The Lender is a registered money lender holding a valid money lenders licence under the Money Lenders Ordinance (Chapter 163 of the Laws of Hong Kong) and is principally engaged in the business of money lending services. Provision of the Loan Facility is a transaction carried out as part of the ordinary and usual course of business activities of the Group. The Loan Facility is funded by internal resources of the Group.

The terms of the Loan Agreement were negotiated on arm's length basis between the Lender and the Borrowers and were on normal commercial terms based on the Group's credit policy. Taking into account the results of due diligence on the financial background and repayment ability of and the collateral given by the Borrowers and the stable interest income expected to be generated from the Loan Facility, the Directors consider that the terms of the Loan Agreement are fair and reasonable and the entering into of the same is in the interests of the Company and its Shareholders as a whole.

IMPLICATIONS UNDER THE LISTING RULES

As the relevant percentage ratios (as defined under the Listing Rules) in respect of the maximum amount of financial assistance granted to the Borrowers or their associates pursuant to the Loan Agreement exceed 5% but are under 25%, the transaction contemplated thereunder constitutes a discloseable transaction of the Company and is therefore subject to the announcement requirement but exempt from obtaining Shareholders' approval under Chapter 14 of the Listing Rules.
