DISCLOSEABLE TRANSACTION

RELATING TO THE PROVISION OF LOAN FACILITY

The Board announces that on 12 August 2015, an indirect wholly-owned subsidiary of the Company entered into the Loan Agreement with the Borrowers for the provision of a loan facility of up to HK\$186,320,000.

Pursuant to Rule 14.06(2) of the Listing Rules, the granting of the Loan Facility constitutes a discloseable transaction of the Company as the relevant percentage ratio(s) exceed 5% but are under 25% and is subject to the announcement requirement as set out in the Listing Rules but is exempt from shareholders' approval requirement under the Listing Rules.

The Board announces that on 12 August 2015, the Lender, an indirect wholly-owned subsidiary of the Company, entered into the Loan Agreement with the Borrowers, under which the Lender has agreed to provide a loan facility of up to HK\$186,320,000 to the Borrowers pursuant to the terms of the Loan Agreement.

THE LOAN AGREEMENT

Date: 12 August 2015

Lender: Emperor Finance Limited, an indirect wholly-owned subsidiary of the Company

Borrowers: the borrowers under the Loan Agreement

The Borrowers are three individuals. To the best knowledge, information and belief of the Directors having made all reasonable enquiries, the Borrowers are independent third parties not connected with the Company or connected persons of the Company.

Principal terms of the Loan Agreement

Amount of the Loan Facility:	up to HK\$186,320,000
Drawdown:	available for drawdown within 1 month upon signing of the Loan Agreement
Repayment:	within 12 months from the date of drawdown
Interest:	13% per annum
Security for the Loan Facility:	the Loan Facility is secured by an all monies first legal charge over a property located in Hong Kong in favour of the Lender as a continuing security for the due performance of the obligations and duties of the Borrowers under the Loan Agreement

REASONS FOR ENTERING INTO THE LOAN AGREEMENT

The principal business activity of the Company is investment holding and its subsidiaries are principally engaged in the provision of financial services in Hong Kong, including (i) commercial and personal lending as well as margin and IPO financing; (ii) brokerage, wealth management and asset management; (iii) placing and underwriting services for listed vehicles; and (iv) corporate finance advisory services.

The Lender is a registered money lender holding a valid money lenders licence under the Money Lenders Ordinance (Chapter 163 of the Laws of Hong Kong) and is principally engaged in the business of money lending services. The provision of the Loan Facility is a transaction carried out as part of the ordinary and usual course of business activities of the Group. The Loan Facility will be funded by internal resources of the Group.

The terms of the Loan Agreement were arrived at after arm's length negotiations between the Lender and the Borrowers. After considering the expected revenue to be generated, the Directors are of the view that the provision of the Loan Facility under the Loan Agreement is on normal commercial terms which are fair and reasonable and in the interests of the Company and its Shareholders as a whole.

IMPLICATIONS UNDER THE LISTING RULES

Pursuant to Rule 14.06(2) of the Listing Rules, the granting of the Loan Facility constitutes a discloseable transaction of the Company as the relevant percentage ratio(s) exceed 5% but are under 25% and is subject to the announcement requirement as set out in the Listing Rules but is exempt from shareholders' approval requirement under the Listing Rules.
