# INTRODUCES CHINA TAIPING INSURANCE AS STRATEGIC SHAREHOLDER BY SHARE SUBSCRIPTION To Raise Net Proceeds of Above HK\$400 million

(Hong Kong, 1 December 2016) **Emperor Capital Group Limited** (the "Group" or "Emperor Capital Group") (Stock code: 717), a one-stop comprehensive financial services institution in Hong Kong, today announced share subscription under general mandate (the "Subscription").

The Group has agreed to allot and issue a total of 612,900,000 shares (the "Subscription Shares") at HK\$0.66 per subscription share (the "Subscription Price") to a company incorporated in Hong Kong, whose ultimate controlling shareholder is China Taiping Insurance Group Limited ("China Taiping Insurance"), a PRC state-owned financial and insurance group. It is also a subsidiary of China Taiping Insurance Holdings Company Limited, a listed company on the Main Board of The Stock Exchange of Hong Kong Limited (the "Stock Exchange") (Stock code: 966).

The Subscription Shares represent (i) approximately 10.00% of the existing issued share capital; and (ii) approximately 9.09% of the enlarged share capital comprising 6,740,845,724 shares. The Subscription Price represents a discount of approximately 19.5% to the closing price of HK\$0.82 per share as quoted on the Stock Exchange today.

The estimated aggregate net proceeds from the Subscription will be approximately HK\$404.5 million, which are intended to be used (i) for expansion of money lending business which include the commercial and personal lending as well as margin and IPO financing, and (ii) for repayment of outstanding loans.

The controlling shareholder of the Group currently holds 2,667,805,360 shares, representing approximately 43.54% of the issued share capital of the Group. Subsequent to the completion of the Share Subscription, the controlling shareholder will hold approximately 39.58% of the enlarged issued share capital of the Group.

Ms. Daisy Yeung, Chief Executive Officer of Emperor Capital Group, said, "China Taiping Insurance is a giant insurance conglomerate in the PRC with long-established brand, leading service standard and sound reputation. I am delighted to welcome China Taiping Insurance as our strategic shareholder by share subscription, which is a vote of confidence towards our management team and future development. Such share subscription not only strengthens our shareholder portfolio, but also provides additional liquidity to fuel our ever-expanding money lending business, driving us to achieve new milestones."
