

## Additional Terms and Conditions for Trading RMB Currency Futures

The following terms and conditions are applicable to USD/CNH Futures:-

- 1. There are differences between the Exchange's Last Trading Day of USD/CNH Futures and the last trading days of other products. Client should take note of the Exchange's notice or announcement all the times. Emperor will not separately notify clients if there are any changes to the Exchange's Last Trading Day. Client should be fully responsible for all the losses whatsoever incurred as a result of any omissions and delay in notifying Client with the relevant information and Emperor shall not be responsible for any liability whatsoever caused.
- 2. Client should take note that Emperor will set our last trading day as ONE TRADIN G DAY BEFORE the Exchange's Last Trading Day. Client should close all their spot month positions by 6 3 0pm ONE TRADING DAY BEFORE the Exchange's Last Trading Day. Otherwise, Emperor reserves the rights to liquidate Client's positions without prior notice. Also, on the Emperor s last trading day and T+1 session (7 15 pm 3 :00 am (next day)) of the previous trading day, Client can only close out spot month positions but cannot open new positions.
- 3. If Client want s to make/take delivery of RMB upon expiration of the contract, Client must give Emperor instructions to make/take delivery for the contract and deliver sufficient funds required in connection with the delivery by 12:00 noon ONE TRADING DAY BEFORE the Exchange s Last Trading Day of the contract.
- 4. If the instructions, or such funds referred to in ( above are not received by Emperor by the time specified, Emperor may at its sole and absolute discretion, without prior notice to Client, either liquidate the position or make or receive delivery on the Client s behalf. Client understand s that he/she shall be responsible for all the expenses incurred by Emperor in connection with the above and Emperor shall not be liable for any loss that may thereby be incurred.
- 5. Emperor may charge debit interest for any outstanding CNY balances caused by Client trading CNY denominated Futures products.

## 有關人民幣貨幣期貨交易之額外條款及條件

以下條款及條件適用於美元兌人民幣(香港)期貨交易:

- 美元兌人民幣香港期貨的最後交易日與其他產品有所不同客戶須自行留意交易所的公佈。英 皇期貨並不會就交易所之最後交易日之更改另作通知,客戶必須承擔因上述資料之遺漏及延 誤通知而引致的全部損失,英皇期貨不會承擔任何相關責任。
- 客戶須注意英皇期貨之最後交易日定為交易所之最後交易日的前一個交易日。客戶必須在每月交易所之最後交易日的前一個交易日下午 6:30 前把即月合約平倉,否則英皇期貨有權替客人強行平倉而不作事先通知。而當日及前一個交易日之 T+1 時段(下午 7 15 翌日上午 3:00) 客戶只可替即月合約平倉,不可開立新倉。
- 如客戶欲在有關合約到期後交付/提取人民幣,客戶必須於交易所之最後交易日的前一個交易日中午 12:00 前向英皇期貨發出相關指示,並向英皇期貨交付足夠款項,以執行指示。
- 如英皇期貨在(3)所述之時限前沒收到相關指示,或沒收到相關款項,英皇有唯一及絕對 酌情權可毋須事前發出通知,代客戶平倉或交收。客戶明白英皇期貨因上述安排而蒙受的開 支,都由客戶承擔;凡可能因此而蒙受的損失,都毋須由英皇期貨負責。
- 如客戶進行任何以人民幣結算的期貨產品交易,並引致帳戶出現人民幣欠款,英皇期貨將會 收取該欠款之借貸利息。
