

### **Loan & Financing Service**

#### **Portfolio of Financing Segment**

#### Term Loan: Bridging loan and structured loan

- Provision of tailor-made loan services and one-stop financial advisory services to substantial shareholders of listed companies for their asset reorganization or M&A projects
- Controlling stakes of listed companies are usually pledged as collateral

#### **Margin Financing**

- Traditional source of financing, the borrowing power depending on the quality of the underlying securities
- Borrowing power ranges from 10% to 70%, with margin interest rates varies from P+3% to P+8%
- Its performance depends on the turnover of equity market, which serves as a relatively stable source of income

#### Others: Mortgage, tax loan and petty loan

- Loan period: 1 year 2 years
- Surging demand for re-mortgage loan from licensed money lenders due to the banks' tightening control over mortgage lending in response to adjustment in property valuation



### **Bridging Loan Market**

#### Solid Clientele Base

Riding on the renowned reputation of "Emperor" and "Emperor Capital Group", we have established a solid base of clientele comprising 2nd tier and 3rd tier listed companies over the years with abundant experience in local market.

#### Interest Income

Monthly interest rate ranges from 1.5% to 3.5%, with loan period from three to nine months.

Thorough assessment on the collaterals to minimise the default risk.




